In addition she asked members to let her know of any questions they may have for Anglian Water (AW), as they will be attending the NNDC 'Overview & Scrutiny Committee' meeting at NNDC on 10th December 2025 = Confirmation from AW is sought on capacity to cope with the proposed number of new houses.

Members asked if buses could run back into Blakeney later in the evening, as the public transport system for this rural area is hugely disadvantaged.
